

# CREATOR FEE SCHEDULE

GO WFO shall pay you the following fees as consideration for license as follows:

## **1. Referral Subscription Fees:**

You shall receive an ongoing recurring commission of 10% from all Subscribers who register using your unique coupon code, so long as they continue paying for the Licensed Service.

## **2. Referral Commissions.**

You will receive 5% of the subscription revenue of other Content Creators you introduce to join the WFO Platform during the first twelve months of their initial registration.

## **3. Video Views Compensation.**

GO WFO will allocate 50% of the Operating Profit (Subscription Revenues less Operating Expenses, loans and interest) from WFO Platform into a Content Creator Pool. *Content Creator Pool* shall be distributed among Content Creators according to each Content Creators' *View Score*, which shall be determined by its *Total Views* (50% weighted) and *Total Time Watched* (50% weighted), whereby each Content Creator will receive an allocation equal to its proportionate percentage of the total *View Score*. Operating Expenses include referral fees, commissions, royalties, affiliate fees, Internet and platform fees, 3<sup>rd</sup> Party expenses, Promotions, professional fees, compensation and miscellaneous expenses for operating the WFO Platform.

## **4. Commissions and allocations from Sponsors and Advertisers:**

You will receive a 15% commission for introducing any sponsors and advertisers ("Sponsor" and "Advertisers") to the WFO Platform, provided Content Creator reasonably assists GO WFO throughout the sales process to close the sale.

## **5. Commissions and allocations for Merchandise:**

You will receive a 20% commission of the sale of WFO merchandise from people who purchase merchandise using your unique WFO COUPON CODE.

## **Payment to Creators:**

All Fees shall be paid within (15) days of the end of each month. Until the WFO Platform has 50,000 Subscribers, *Video Views Compensation* will be calculated and paid on a quarterly basis (this does not include referral fees, or fees associated with Sponsors, Advertisers and Merchandise). Without limiting the foregoing, GO WFO makes no representations or warranties concerning any financial outcome resulting from this License

## **Payment Directions:**

Unless and until GO WFO is otherwise notified by you, all future payments shall be provided by wire transfer payments, as designated by you.

**Maintenance of Records.** GO WFO shall maintain accurate records of Subscriptions, Sponsor and Advertiser Fees paid to the WFO Platform for at least three (3) years after the

conclusion of any given Calendar Quarter, during which time Licensor will have the right, at its expense to inspect such records during normal business hours for the purposes of verifying the accuracy of any reports and payments delivered under this Agreement and GO WFO's compliance with the terms hereof. In the event of any underpayment or overpayment, GO WFO shall reconcile any underpayment or overpayment within ninety (90) days after the accountant delivers the results of the audit. If any audit performed under this provision reveals an underpayment in excess of five percent (5%) in any calendar year, GO WFO shall reimburse you for all amounts incurred in connection with such audit. You may exercise your right under this section once per calendar year with reasonable prior notice.
